Law Incident Narrative:

The complainant stated he and his cousin were standing outside when the suspects pulled up in the listed vehicle. He stated when they got out he was hit in the face and suspect Brown took listed property from him while two of the other suspects were holding him and his cousin at gunpoint. Victim Terry Wilson stated because they had guns he got. scared and ran. Victim Romanitha Wilson stated she looked out the door and started yelling for the suspects not to shoot her cousin and they pointed a gun at her. She advised they had what appeared to be a Tech 9 and an automatic rifle. She showed officers where she believed the suspects had gone. Upon arrival officers saw the vehicle. Found suspect Brown hiding in a bedroom closet. Upon checking further a Tech 22 automatic was found loaded in the same closet. As officers checked premises they found a Russian SKS in the front room. Suspect 2 is Kevin Rice, address 1393 Standridge, 5"9, 275 pounds, 18 years of age, male black, black hair, brown eyes, low cut beard, heavy build, light complexion, low cut hair style, street name is "Big Wam".

Law Supplemental Narrative:

Supplement #1

On Sunday, January 5, 1997, at about 7:10pm, Cedric Wilson was out in front of 2510 Dexter, when a blue Cadillac pulled up, occupied by 4 black males, two of whom were armed with guns. These assailants got out of the car, at which time Mr. Wilson was cut when he was struck in the mouth with the pistol. A watch, beeper, shoes, and \$150 cash was taken from Cedric Wilson during this incident. His cousin, Romanitha Wilson, was standing in her doorway at 2510 Dexter, which was occupied by several other people (including small children) at the time of this incident. Ms. Wilson went out to the street to try and prevent the assailants from shooting her cousin, at which time one of the assailants pointed a gun directly at her and threatened to shoot up the house. The victims knew three of the suspects by name, advising that Dante Dale had struck Cedric in the mouth and held him at gunpoint while the suspect not known to them took Cedric's shoes, beeper, watch, and money. The victims stated that Kevin Rice had a "big long gun" and threatened to shoot into Ms. Wilson's house, and that Etienne Harmon was with the other three suspects at the time of this incident. The victims called police immediately and took them to the neighborhood where the suspects lived, at which time the blue Cadillac was located in front of 1393 Standridge, where Auan Brown was found hiding in a bedroom closet with a Tech-22 pistol which had an extended clip. A Russian SKS assault rifle, with a 20 round clip and a 100 round clip, was also recovered from this house at that time. Auan Brown was positively identified by the victims as the fourth subject responsible, and was arrested on the same day as this incident. Both victims positively identified Dante Dale, Kevin Rice and Etienne Harmon from photospread line-ups, and they

were then subsequently arrested Auan Brown refused to give a statement in this matter. Dante Dale admitted to striking Cedric Wilson, because Cedric had supposedly stolen a large sum of money from him about a year and a half ago, but denied the involvement of any weapons. He implicated Kevin Rice, Etienne Harmon and Auan Brown as having been with him at the time of this incident, and stated that Auan Brown had removed Cedric's shoes. but threw them in the yard at 2510 Dexter before they left. Kevin Rice admitted to being present at the time of this incident, but stated that he and Etienne Harmon had stayed in the car while Dante assaulted Cedric Wilson. He further advised that Auan Brown took Cedric's shoes, watch and beeper, but threw them all back in the yard before they left. Kevin Rice also denied the involvement of any weapons. Etienne Harmon admitted to being in the Cadillac while Dante Dale beat up Cedric. Wilson. He stated that Kevin Rice just stood by the car and that Auan Brown, who had a gun in his waistband that he never pulled out, took Cedric Wilson's shoes, beeper and watch, which were thrown in the yard before they left. Dante Dale, Kevin Rice and Auan Brown were charged with Aggravated Robbery and Aggravated Assault in connection with this case. Etienne Harmon, who was a juvenile at the time of this incident, was charged with Evading Arrest (from having run from police at the time of his arrest), which was handled entirely through Juvenile Court me him available as a witness in this matter

She gave the writer Cedric's pager number and advised that she would give him a message to call the Robbery Office. She also stated that Terry and Romanitha are brother and sister, and are Cedric's cousins. At 1:34pm, the writer called Cedric Wilson's pager number. At 1:34pm, the writer called the home number listed for victim Romanitha Wilson, at which time she advised that nothing was taken from her. She stated that suspect Kevin Rice pointed an AK47 at her and told her to "get back and get out of the way," and for her to "get your kids out of the house 'cause I'm going to shoot your house up." She also advised that they know the suspects from years ago in the neighborhood, and that the person arrested last night had hit and kicked Cedric and took items from him. At 1:41pm, the writer spoke with victim Terry Wilson, who was at Romanitha's house. He stated that he and Cedric were outside talking to some friends when the Cadillac pulled up and the suspects jumped out. He advised that he and the friends ran off, and that items were taken from Cedric. He also advised that Donte Dale (aka "Big Daddy"), who was driving the Cadillac, had a 9mm handgun. Both advised that they would come in tomorrow (1/7/97), at 10:00am, to give a formal written statement, and that they would try to locate Cedric in order to bring him with them. At 2:25pm, the writer located arrest histories on the defendant and the other named suspects in this case. Pictures were ordered of the adults and the writer contacted Juvenile Court about the one juvenile, A search of Spillman showed prior involvements on all subjects. MRW 9486 Mon Jan 6 15:29:55 CST 1997 TUESDAY (1/7/97) The victims did not show up for their scheduled appointments, so the writer called again, at which time they advised they would be in tomorrow (1/8/97). WEDNESDAY (1/8/97) Cedric, Terry and Romanitha Wilson all showed up at the Robbery Office to look at pictures and give formal statements in this case. At 9:33am, Cedric Wilson gave a signed statement advising that he was robbed and beaten by four M/B's, two of whom he knew only by the nicknames of "Big Daddy" and "Big Wham." He advised that "Big Daddy" had struck and cut him in the mouth with a gun, and that another suspect took his watch, beeper, shoes, and \$150 cash. At 10:59am, Cedric Wilson positively identified standing by the Cadillac during this incident. At 11:11am, Cedric Wilson positively identified Dante Dale as the suspect he knows as "Big Daddy" and the one who had struck him with the pistol and taken his money and beeper. At 11:18am, Cedric Wilson positively identified Kevin Rice as the suspect he knows as "Big Wham" and the one who had pointed a "big long gun" at Terry and Romanitha and threatened to shoot up the house. At 11:31am, Romanitha Wilson gave a signed statement advising that Dante Dale ("Big Daddy"), Kevin Rice ("Big Wham"), 📳 subject arrested the day of this incident (whom she does not know) drove blue Cadillac. The subject she did not know took Cedric's shoes, beeper, watch, and money, and Kevin Rice threatened to shoot up into her house. At 12:25pm, Romanitha Wilson positively identified 🛤 being present at the time of this incident. She advised that he got out of the Cadillac, but really didn't do anything during this incident. At 12:39pm, Romanitha Wilson positively identified Dante Dale as "Big Daddy," and the one who had pulled a gun on Cedric and made him get on At 12:48pm, Romanitha Wilson positively identified Kevin Rice as "Big Wham," and the one with the long gun who had threatened to shoot up in

her house.

WEDNESDAY (1/8/97)

The writer charged Auan Brown with Aggravated Robbery and Aggravated Assault in connection with this case. After hearing the circumstances, these charges were approved by Asst. D.A. Paul Goodman.

TUESDAY (1/21/97)

At 7:13pm, Kevin Rice was arrested at 1893 Standridge.

WEDNESDAY (1/22/97)

At 1:10pm, the writer advised Kevin Rice of his rights in the Robbery Office, at which time he signed a waiver to talk to the writer without an attorney present. He then gave a signed type-written statement admitted to having been present at the time of this incident, but denied any personal involvement in it.

The writer then explained the circustances of Kevin Rice's involvement in this case to Asst. D.A. Johnny McFarland, who approved charges of Aggravated Robbery and Aggravated Assault.

THURSDAY (1/23/97)

At 9:00am, Dante Dale was arrested at his home, 1326 Standridge, and brought directly up to the Robbery Office.

At 9:45am, Dante Dale was advised of his rights and signed a waiver to talk to the writer without an attorney present. He then gave a signed type-written statement admitting to having struck Cedric Wilson, because of some money that Cedric had supposedly stolen from him about a year and a half ago, but denied that any weapons were involved. At 11:20am, Etienne Harmon was arrested at 1364 Standridge after a brief foot pursuit. He was brought directly up to the Robbery Office. At 1:40pm, after his mother, Diane Brown, finally arrived, Etjenne Harmon was advised of his rights and signed a waiver to talk to the writer without an attorney present. He then gave a signed type-written statement admitting to having been present at the time of this incident, but denied any personal involvement in it. He was then transported to

FRIDAY (1/24/97)

Juvenile Court.

The writer relayed the facts of this case, regarding the involvement of Dante Dale and Etienne Harmon, to Asst. D.A. Michael Leavitt, who then authorized charges of Aggravated Robbery and Aggravated Assault on Dante Dale. He agreed with the writer that Etienne Harmon should be charged only with Evading Arrest

The writer formally charged Dante Dale and Kevin Rice with Agg. Robbery and Agg. Assault on this date. Charges of Agg. Robbery and Agg. Assault against Etienne Harmon were also dropped on this date.

There were never any guns involved and why they said there were I don't know. Dante was the only one who assaulted Cedric. Q: Who else was out there with Cedric at the time? A: His cousin named Terry was out there at the time and his cousin Romanitha was in the house, she didn't come out until after the tussle was over and Cedric went in the house. Q: What part did you play in this incident? A: I just sat in the car and watched. Q: Do you know what happened to Cedric's property that was taken? A: It was thrown back in the yard after the incident and before we Q: So Cedric got everything back that night? A: I heard Dante tell Auan to throw the stuff back in the yard, but I only saw the shoes get thrown back. It was dark outside, so I couldn't tell if Auan threw the watch or beeper back or not. Q: What kind of guns were used and who had them? A: There weren't any guns, not even in the car. O: Who's guns were found at 1393 Standridge the night Auan was arrested? A: I have no idea. Q: Who lives at 1393 Standridge? A: Alberta Freeman, Sharon Freeman and Karen Freeman. Q: Do you know why Cedric was robbed and beaten? A: I guess it was over the money that he owed to Dante. Q: Can you tell me about the money that Cedric owed to Dante? A: It was about \$1,400 that Dante gave to Cedric to buy drugs with. Q: What happened to this money A: I have no idea. Cedric left with the money and nobody seen him again until that day Q: How long ago did Dante give this money to Cedric? A: About two or three years. Q: And your saying that Sunday, January 5, 1997, was the first time that Dante has seen Cedric since he gave him this money 2-3 years ago? A: Right. Q: Do you know Cedric and his cousin, Romanitha, personally? A: I'd know them when I see them, but I don't really just associate Q: Do you go by any nicknames? A: Yeah, "Wham" and "Big Wham."

Q: Does Dante or Share go by any nicknames? Dante ("Big Daddy") and Auan was the only two that got close to Cedric, which was about 25 feet away from the car. Auan didn't really touch him, except to take his stuff. Dante was the only one that beat him up. Q: Do you know why this incident happened? A: Because Ced stole some of Dante's money and ran off with it. Q: How did Cedric steal Dante's money? A: Dante said Cedric stole it out of his car, out of the glove compartment. Dante told me that he told Ced to get the money out of the glove box and bring him the package, but Ced ran off and didn't come back. Q: How much money did he take? A: It was close to \$2,000 or \$3,000. Q: How long ago did this happen? A: It happened in 1994. Q: Why did Dante wait until this year to get mad at Cedric about the missing money? A: He had been looking for him, but he never could catch up to him, and when he would catch up to him Ced would run off. Q: Do you know why Dante never reported this theft to the police? A: I don't know if he did or not. Q: Do you know where Dante got this money that Cedric took? NOTE: AT THIS POINT MOTHER INTERVENED AND STATED THAT SHE DID
