Title: Report Narrative  
On 08/05/2015 at 11:35 hours, Officer N Russell (11411) responded to a Simple Assault in the area Trezevant/Shasta. Upon arrival officer was advised by home owner/witness Sylvester Sullivan at 2290 Shasta that he currently owns the property located at 2274 Shasta. Witness Sylvester Sullivan and his wife/ suspect Toni Ellis advised officers that the property at 2274 is owned by both parties and provided officers with documentation showing ownership of the property. However while officers were on the scene learned of an assault that possibly took place between suspect Toni Ellis and victim Stephanie Ford. Victim Stephanie Ford stated to officers the property is a project of Grow Memphis and houses several plants, vegetables, and foods. Victim Stephanie Ford advised this project has been in place for 4 years and she is a volunteer with Grow Memphis and was over at the property harvesting when she was approached by suspect Toni Ellis and witness Sylvester Sullivan. Victim Stephanie Ford stated that while over on the property, suspect Toni Ellis came over onto the property and told her the property was a no trespassing property with a visible sign posted and she was calling the police on her. At this time victim Stephanie Ford advised as she began to exit the property to avoid any altercation suspect Toni Ellis blocked her from exiting the property and pulled her by her Hoodie and hit her twice in the back. Victim Stephanie Ford then stated after being assaulted suspect Toni Ellis stated to her ".... I should fuck you up being here and your lucky I don't blow your brains out.....". Officer didn't observe any signs that the victim had been assaulted. However, a photo was taken for documentation purposes of the back of Stephanie Ford's neck, where she indicated she was hit. Officer then spoke back to suspect Toni Ellis who stated she only approached the victim about being on the property and then returned back across the street with her husband to gather paper documentation on the property. Suspect Toni Ellis denied assaulting the victim. Officers then spoke to witness Sylvester Sullivan who advised also that they encountered the victim and produced the paper work and that no assault occurred. Officer advised all parties on the property issue and it's ownership as well as property lines should be addressed by a judge in court. Prior to clearing the scene victim stated to officers that they have been working on this property for quite sometime harvesting plants, vegetables, and foods and believes that due to profit gains that this has just recently become an issue.
