AFFIDAVIT OF COMPLAINT

Personally appeared before me day of Memphis, TN 38109, did unlawfully commit the offense(s) of Tinted windows (T.C.A. 55-9-107), Driving While License Suspended/Revoked/Cancelled (T.C.A. 55-50-504), Improper Display of Motor Vehicle Tags (T.C.A. 55-4-110), Possess Controlled Substance w/i to Manufacture/Deliver/Sell (T.C.A. 39-17-417), Possess Controlled Substance w/i to Manufacture/Deliver/Sell (T.C.A. 39-17-417), Resisting Stop, Arrest (T.C.A. 39-16-602) and the essential facts constituting said offense(s) and the source of the affiant's information are as follows:

On 07/06/2018 at 18:25 hours, Multi-Avency Gang Unit Detectives were saturating the area of Sharpe/Robin Hood Ln as part of Operation Summer Heat conducting traffic stops. Detective P Petty (12062) was travelling northbound on Robin Hood Ln and observed a white Infiniti FX35 with TN Tag Z73-35J travelling southbound on Robin Hood Ln with extremely dark tinted windows all around the vehicle. Detective Petty turned around to conduct a traffic stop and the white Infiniti immediately made a left turn into the driveway of 1626 Robin Hood Ln, which is a vacant residence. Detective Petty pulled behind the Infiniti and initiated blue lights and sirens to let the driver know of the traffic stop. When Detective Petty pulled behind the vehicle he also saw that the vehicle license plate has a frame over it blocking the county sticker the vehicle is registered to. Detective Petty made contact with the driver and only occupant of the vehicle, Keedran Franklin. Detective Petty advised Keedran of the reason for the traffic stop and immediately smelled a strong odor of raw marijuana coming from the interior of the vehicle. Detective Petty asked Keedran for a driver's license and proof of insurance. Detective C Mills (12810) then pulled onto the scene to assist. Detective Petty checked Keedran through NCIC and found him to have a suspended license as of 02/27/2017 for failure to answer/pay original violation. Detectives then asked Keedran to step out of the vehicle at which time he refused an stated, "I have to give y'all permission to check my vehicle". Detectives advised Keedran again to step out at which time he got up from the driver seat and stood by the driver door. Detectives attempted to detain Keedran by placing handcuffs on him, but he started to pull away after Detective Mills placed a cuff around his right hand. Detective Mills was able to hold on to the cuff to keep Keedran from breaking away and running away. Detective Petty was able to get a hold of Keedran Towner left hand and place it behind his back. Keedran kept pulling away as Detectives yelled at him to stop resisting and comply with detectives orders. Keedran kept pulling away at which time detectives took Keedran to the ground to keep him from getting away. Keedran sustained a small abrasion to his left elbow from landing on the concrete. Detectives got on their primary channel and advised for other team members to pull over and assist. All other team members with the Multi-Agency Gang Unit GRT including the supervisor Lt K Brown (0045) pulled over to assist. Detectives were able to get Keedran in custody after a brief stuggle. Detective Mills then utilized his NNDDA certified K-9 Mambo due to the strong odor of marijuana coming from vehicle. Mambo gave a positive hit on the back passenger seat by some clothes that was wrapped up. Detective J Harkness (12034) checked the backseat and located a large clear plastic bag containing a green leafy substance consistent with marijuana. Detective Harkness also located a smaller clear plastic bag containing what appeared to be illegal mushrooms. Detective Harkness also located a small clear plastic bag of supposed marijuana in the center console along with \$190 in cash and a purple grinder commonly used to grind up marijuana for smoking. Detective Stewart (12609) patted down Keedran incident to arrest and located \$500 in currency on his person. Detective Molder (\$9918) tagged all the evidence at 201 Poplar Ave Property and Evidence Room where the marijuana tested positive for THC using the Duquenois test and weighed 114.7tgw. The mushrooms were tested using the Psilocin Reagant test which tested positive for Psilocybin and weighed 19.0tgw. Detective J Harkness checked the window tint using his tint meter and the tint registered at 27%. These events occurred in Shelby County, Tennessee.
