The second officer searched me and I was placed in the back of his car, then he was called for something and I was taken out of his car and placed in the back of her car after being searched another time. The first officer did search me before placing me in hand cuffs. I told both officers that I couldn't sit down, because the hand cuffs were hurting real bad, that's when the other officer saw that one pair of cuffs wasn't going to work and he gave the other officer an extra pair to put on me.

After being placed back in the first officers car a tow truck was called to pull the car and he couldn't

start it and I was taken out of the car to show the tow truck driver how the car is started, we drove to a gas station so the young lady could call someone to come and get her.

On the way to 201 poplar the officer called in her transport. A few minutes later a car pulled along side I looked at the car GRAY 4 DOOR with dark tinted windows and it had prime spots all over it like, it had been in the body shop. I turned to look forward and I heard like three shots. I got down on the floor of the car as I did the car speed up and a to the left hit something and stopped. When I look up the other car was still going forward and the break lights came on and the car looked like it was turning around, but it didn't.

I turned to see if the officer was OK, asked her if she was alright and never got an answer.

I took my feet and kicked out the glass from the back window that shattered, dove through the window onto the ground and took my time to take the hand cuffs underneath me, placing my leg through one at a time and stood up and opened the front passenger door and crawled in to check the officer and she just fell to the right across the front seat. I tried to see if she was breathing and prest on her chest to try and get a response, there wasn't anything and no blood any where. I took the hand cuff key from her belt and as I taking off the cuffs I looked down the street to make sure the same car wasn't coming back because I had seen some head lights in the distance I took her gun from the holster and walked about two blocks before throwing the cuffs in the trash can behind the laundry mat.

and just walked until I got a ride to the bus stop down town where I caught the bus to my moms house. When I got off at the bus stop I walk down the street right pass and under cover officer sitting, two houses down from my mothers house and walked right past him down the street, were another officer was sitting and walked right past him to a friends house and made a phone call to my grandmother, a call to my cousin, a call home and a call to a family friend that I was going to turn myself into, but some how a friend in the neighborhood seen me and told them where I was and I was arrested, kicked, beaten, choked and slapped around, before being placed into an officers car. Since I had time after I called to turn myself in I hid the officers gun under the front passenger seat of a car that belonged to a friend that turned state witness due to the Fed watching all well

known car thief, that was a gang member, of which a deal was made for him to testify against me. How else could they pack up and move out of the neighborhood over night. I've shown the gang members my paper work while I've been in prison and they them selves are still looking for him. He were helping his mother with all her bills, when all this happend everyone stopped paying her bills so how can you move over night without any money unless you where paid to turn state witness on someone.

There is no way your going to move unless they paid you or you are put into a witness protection of some sorts.
