[Case 090318 Supplement, Officer: POSTON, ALEX 4439]

On 07/08/2009 Detectives Poston and Jewell received information from a reliable informant that Thorne PETERS is selling Marijuana from Imbibrio's Bar located at 6353 Navy Rd. Detectives recorded a phone call from the reliable informant to PETERS. PETERS agreed to sell the informant a half ounce of Marijuana for \$50.00. PETERS also agreed to meet the informant at Imbibrio's Bar on Thursday night (07/09/2009) to complete the transaction. A compact disc of the recorded phone call was taken to the MPD Property Room and tagged. This did occur in Shelby County, TN.

[Case 090318 Supplement, Officer: JEWELL, R S4396]

On 07/08/2009 at approximately 2200 hours Detectives Poston and Jewell received information from a reliable informant that Thorne PETERS is selling Marijuana from a nightclub named Imbibrio's located at 6353 Navy Rd. in Millington, TN. This reliable informant has given information in the past to Detectives which has resulted in numerous seizures of controlled substances and numerous arrests for felony narcotics charges, consistent with the information provided. Detectives recorded a phone call between the reliable informant and PETERS. PETERS agreed to sell the informant a half ounce of Marijuana for \$50.00. PETERS further stated the informant could obtain the Marijuana from him at Imbibrio's the following night (07/09/2009). PETERS then instructed the informant to make a follow up phone call to him before the informant arrived to make sure PETERS would be in possession of the Marijuana. A compact disc of the phone call was taken to the MPD Property Room and tagged under receipt #090700756.

On 07/09/2009 at approximately 2115 hours Detectives recorded a second follow up phone call between the informant and PETERS. PETERS agreed to sell the informant Marijuana and that the informant could pick up the Marijuana at Imbibrio's. PETERS further stated during the phone call that he was going to call his source of supply to obtain the Marijuana. Based on the information Detectives Poston and Jewell obtained \$50.00 of official Shelby County Sheriff's Office Narcotic funds on receipt #06561 for this purchase. Detectives checked the informants person and vehicle prior to the buy with negative results for illegal substances. Detectives then followed the informant to 6353 Navy Rd. (Imbibrio's) and observed the informant to enter the business. Approximately thirty minutes later Detectives met the informant at a pre-arranged location. The informant produced 7.75g T&W Marijuana and stated the purchase was made from Thorne PETERS while inside Imbibrio's. A compact disc of the telephone call and the Marijuana was taken to the MPD Property Room and tagged under receipt #090700756. This did occur in Shelby County, TN.

[Case 090318 Supplement, Officer: JEWELL, R S4396]

On 07/13/2009 at approximately 2130 hours Detectives Poston and Jewell received information from a reliable informant that Dustin WEBSTER is selling Lortab pills (Schedule III Narcotic) from 6353 Navy Rd. (Imbibrio's) in Millington, TN. This reliable informant has given information in the past to Detectives which has resulted in numerous seizures of controlled substances and numerous arrests for felony narcotics charges, consistent with the information provided. Detectives Poston and Jewell obtained \$60.00 of official Shelby County Sheriff's Office Narcotic funds on receipt #06575 for this purchase, which was photocopied. Detectives checked the informants person and vehicle prior to the buy with negative results for illegal substances. Detectives then followed the informant to 6353 Navy Rd. (Imbibrio's) and observed the informant to enter the business. Approximately ten minutes later Detectives met the informant at a pre-arranged location. The informant produced ten (10) Lortab pills and stated the purchase was made inside Imbibrio's from Dustin WEBSTER. The evidence was taken to the MPD Property Room and tagged under receipt #090701060. This did occur in Shelby County, TN.

[Case 090318 Supplement, Officer: JEWELL, R S4396]

On 07/14/2009 at approximately 2222 hours Detectives Poston and Jewell received information from a reliable informant that Thorne PETERS and a female white known only as "SHERRY" are selling Lortab pills (Schedule III Narcotic) from 6353 Navy Rd. (Imbibrio's) in Millington, TN. This reliable informant has given information in the past to Detectives which has resulted in numerous seizures of controlled substances and numerous arrests for felony narcotics charges, consistent with the information provided. Detectives Poston and Jewell obtained \$40.00 of official Shelby County Sheriff's Office Narcotic funds on receipt #06575 for this purchase, which

was photocopied. Detectives checked the informants person and vehicle prior to the buy with negative results for illegal substances. Detectives then followed the informant to 6353 Navy Rd. (Imbibrio's) and observed the informant to enter the business. Approximately ten minutes later Detectives met the informant at a pre-arranged location. The informant produced six (6) Lortab pills and stated the purchase was made inside Imbibrio's from a female white known as "SHERRY", who is employed as the bartender. The informant stated PETERS had just left the business. The informant also stated "SHERRY" accepted the \$40.00 payment and stated Thorne PETERS left the Lortab inside a clear plastic baggie beside the cash register which was on the bar in plain view. The informant retrieved the baggie and exited the bar. The evidence was taken to the MPD Property Room and tagged under receipt #090701163. This did occur in Shelby County, TN.

On 07/15/2009 Detectives met the informant and recorded a follow up phone call to Thorne PETERS in reference to the probable cause buy made on 07/14/2009 at 6353 Navy RD. (Imbibrio's) from a female white "SHERRY". PETERS admitted knowledge of the Lortab sold by "SHERRY" the previous night to the informant. The evidence was taken to the MPD Property Room and tagged into evidence. This did occur in Shelby County, TN.
